*Dear Bride To Be,*

*Thank you so much for choosing Shearly Chic Hair Design to style your hair on your very special day. In this contract I will explain in detail all information needed for the Bride and the wedding party. Please feel free to contact me via phone, text or email if you have any questions at any time. Upon agreeing to this contract there will be a \$200 non-refundable deposit to reserve the day.*

*The Bridal package will include a trial run of the chosen style. We will book an appointment lasting 90 minutes, to include the trial as well as talking together about the details of your wedding day. Since the styling will take place outside of Shearly Chic Hair Design I require a payment of \$1 per mile both to and from the venue. If accommodations are needed we will also need to discuss and set up the arrangements at least 1 month prior to the wedding day.*

*Bridal Package:*

*Brides Trial Appointment (1 ½ hour) \$85*

*Brides Style Day of the Wedding \$130*

*\$1 per mile traveled to and from venue*

*Bridesmaids/ Mothers/ Flower Girls wanting a special style will need to arrive with DRY hair, unless we will be doing a blow-dry style only. If anyone arrives with wet hair wanting more than a blow-dry style there will be an additional charge of \$50. A blow-dry style is to be done on freshly washed hair and includes a blow-dry with a round brush and products needed to hold the style. A special style to be done on dry hair includes curling/ironing the hair and pinning it up or back as well as any products needed to hold the style. Shearly Chic Hair Design will provide all of the supplies needed including products, hairsprays, curling/straightening irons, brushes and bobby pins. If something extra is wanted for the style such as barrettes, flowers, tiaras or veil that is not my responsibility, please have this available on the wedding day.*

*Bridal Party:*

*Special Style \$85*

*Blow-dry Style \$55*

*If another stylist is required to assist me, due to a large Bridal Party he or she will be required to follow this contract as well. You the Bride have the option of meeting this stylist before the wedding if you choose.*

*Finally we need to know of any known allergies at least 30 days prior to the wedding date. Failure to do so will keep Shearly Chic Hair Design and Stylist free from liability in the result of an allergic reaction.*
